**Objectives:**

The basic aim of the subject is to prepare students to the proper understanding of issues concerning natural environment in order to use them for the needs of tourism as a branch of a balanced economic development of the country.

**Learning outcomes:**

- the ability to evaluate the usability of geographical space for the needs of tourism
- to use cartographic analyses in tourism
- to use knowledge of geography to create a tourist product

**Course contents:**

- to define basic terms from the range of nature rudiments in the town planning of tourism and recreation development in respect to the natural environment shaping and protection
- to discuss research concepts and procedures used in planning and tourism development
- to discuss processes of natural environment degradation occurring as a result of the tourist exploitation of the area

- to discuss theoretical foundations of the natural (geographical) environment valorization for the needs of tourism
- cartography as a system of transmitting information (including geography)
- to discuss selected tourist regions of Poland, Europe and non-European countries

**Teaching methods:** lecture, classes: multi-media presentations, discussions, map exercises, field classes – extramural course

**Assessment methods:** attendance, class participation, in class presentations, credit with a grade, examination after the second semester
